1. COLOCATION PRICING: GENERAL PRINCIPLES

- The Colocation Services pricing model applies to all Colocation Services provided at the Aruba Data Centre.
- Colocation Services are fully operated by Euronext. Order forms and contracts governing the provision of these new services must be signed with Euronext.
- Euronext Colocation Services are available to Members and Non-Members.
- Different prices are applied to Members and Non-Members and are indicated in EUR.
- Application Services fees relate to prices for multicast services in colocation.
- Application Services fees are charged per service and per FTE.
- Participant Access fees are charged per service on a per End User basis. A client of a Service Provider is considered as an End User when he receives raw Euronext Data.
- Colocation Services are invoiced by Euronext directly to Members and Non-Members. Billing will be automatic, regardless of whether the Colocation Services have been used by the Client or not. Full payment is due for every calendar month.
- Euronext may at its sole discretion allow its clients to subscribe on a non-discriminatory basis to temporary validation tests or comparable undertakings regarding new or ancillary Colocation Services, which may give rise to different Charges as set forth herein.
- Charges set out herein that are not amended by means of this updated Price List may be amended by Euronext at a later stage in 2023.
- Detailed Colocation pricing is described in this Price List.

2. EURONEXT COLOCATION PRICE LIST

A. Hosting Colocation Services

The following guide provides an overview of the pricing for Euronext Colocation Services.

Euronext offers a range of Colocation Services to Euronext Members and Non-Members. Specific conditions and pricing may be applied. Please refer to the Colocation Agreement Order Form.

Members/Non-Members:

- A **"Member"** is any entity that is classed as a member, as defined in the General Terms and Conditions (GTCs)
 - Note that an entity that trades via a broker or a clearing firm will be considered as a **"Member"** for pricing purposes only.
- A **"Non-Member"** is any entity that is not a Member, but which is a party to an Other Euronext Agreement:
 - A Service Provider Agreement:
 - Application Service Provider (ASP)
 - Extranet Service Provider (ESP)
 - A Data License

The table set forth below indicates what type of Charges apply to you as a Client depending on your own status and that of any Affiliates or End-Users you may be authorised to service under the Agreement. Euronext's qualification of a Client shall be binding upon the Client.

For the sake of clarity, line 1 means "if the client is a Member, the Client will pay Member Fee".

Colocation cabinets and hosted users

There are three (3) cabinet options available in the Colocation area: **4kW, 9kW or 18 kW of peak power**.

There are two (2) cabinet options available in the Proximity area: **4kW or 9kW of peak power**.

Each cabinet is provided with a power distribution unit (PDU) by default.

Pricing for Non-recurring Fees is the same for Member and Non-Member.

Effective date: 1 January 2023

The Charges regarding Cabinets applicable before 1 January 2023 include a fixed amount for energy and cooling as pass-through costs. Due to the high volatility in respect of the underlying energy prices, Euronext will also pass-through the price increases Euronext has already absorbed in relation hereto. If the cost of energy decreases during the course of 2023, the pass-through costs for Clients will also decrease accordingly.

In order to provide transparency to Clients on the nature of the pass-through costs, Euronext has distinguished the variable pass-through costs for energy and cooling from the other applicable fixed Charges per Cabinet size (applying a 75% usage rate) as reflected in the Price List below. The P&C Unit costs will be communicated by Euronext on a monthly basis.

The pass-through of energy and cooling costs is not to be perceived as an increase of the corresponding Charges of Euronext, though is solely as a pass-through cost in accordance with the Agreement.

3. EURONEXT CROSS-CONNECTIONS WITHIN THE COLOCATION PRICE LIST

A. Colocation Room to Euronext Matching Engine

The Charges set out in this section are not amended by means of this updated Price List and may be amended by Euronext at a later stage in 2023.

Multiple single-mode optic fibre links are needed by Clients to connect their equipment to the Exchange. These links are used either for unicast or multicast traffic.

Connectivity between the Client's cabinet and the Exchange is provided by:

1. Multicast FTEEx: a pair of single-mode fibre links for multicast A & B feeds
2. Unicast FTEEx: A pair of single-mode fibre links for TCP/IP connection (Order Entry Gateway, Drop Copy) with full resiliency

Please note that, as per RTS 10 requirements, Euronext will arrange for the same cable length for all clients when required by Applicable Law.
